The minor in Outreach Education is for students who wish to become effective developers and implementers of non-formal educational programs in community settings. This minor would be especially helpful for students who wish to understand and integrate the concepts of leadership; program development and evaluation; non-formal education; communication and volunteer management. It will be useful for students interested in working with governmental, public and/or private organizations that provide outreach education related to youth development, human wellness, social sciences, food, agriculture, environment and other life sciences.

A minor in Community Outreach Education consists of 12 hours chosen as follows:

COMLDR 3330 (3), 3530 (3), 5330 (3), 5335 (3)

This minor is not available to students majoring in Agricultural Communication, Agriscience Education, or Community Leadership.

At least six credits must be at the 3000 level or above.

Community Outreach Education minor program guidelines

The following guidelines govern this minor:

Required for graduation No

<u>Credit hours required</u> A minimum of 12 credit hrs. 1000 level courses shall not be counted toward the 12 credit hr minimum.

<u>Transfer and EM credit hours allowed</u> A student is permitted to count up to 6 total hours of transfer credit and/or credit by examination.

Overlap with the GE A student is permitted to overlap up to 6 credit hours between the GE and the minor.

Overlap with the major and additional minor(s)

- The minor must be in a different subject than the major.
- The minor must contain a minimum of 12 distinct hours from the major and/or additional minor(s).

Grades required

- Minimum C- for a course to be listed on the minor.
- Minimum 2.00 cumulative GPA for all minor course work.
- Course work graded Pass/Non-Pass cannot count in the minor.
- No more than 3 credit hours of coursework graded Satisfactory/Unsatisfactory may count toward the minor.

<u>X193 credits</u> No more than 3 credit hours of x193 may count toward the minor.

<u>Minor approval</u> Not required as long as students complete the courses as indicated on the minor program description.

<u>Filing the minor program form</u> The minor program form must be filed at least by the time the graduation application is submitted to a college/school counselor.

<u>Changing the minor</u> Once the minor program is filed in the college office, any changes must be approved by filing a petition for change in the minor through the academic unit offering the minor.
